Privacy Policy - Please Review the Following Policy and Private Information Statement!

Purpose - F.A.S.T. (Firethorne's Alert System via Texting) is solely for providing emergency information for the Community of Firethorne and its residents. It will not be used for event announcements, personal use, advertisements, or any other purpose except for emergencies. Only Firethorne's H.O.A. and the Firethorne Crime Watch Committee manages F.A.S.T. This is not a substitute for contacting 9-1-1 for any emergencies requiring Police, Fire, or emergency personnel.

Scope - Firethorne Community Association (Firethorne CAI) values your privacy and your information. We will never sell, lease, share, rent, or barter ANY of your personal information to anyone outside of our organization.

Information We Collect About You

- Firethorne CAI will only collect personal information that will help us to identify you, authenticate you, and provide you with these SMS Alert messages. We will only collect your Name, Cell Phone number, Cell Phone Carrier and your consent to this free service.
- Firethorne CAI will not knowingly collect personally identifiable information from children under the age of 18 without the consent of a parent or guardian. Moreover, we require children to use F.A.S.T. only with the permission of and in conjunction with a responsible adult, i.e., a parent or guardian.

Text Messaging/SMS Charges May Apply based on your Cell Phone Provider's Plan - F.A.S.T. is a free service with no cost to you for text messages. However, you are responsible to verify if your cell phone provider provides text messaging/sms services to your phone and what your costs will be for such services. Firethorne is not responsible for any charges incurred by your account when we send these emergency messages. Please contact your service provider regarding your Text Messaging Plan.
